**Limited Warranty**

Retco Trailer Manufacturing (warrantor) warrants its manufactured equipment to be free from defects in material and workmanship on the frame ONLY for a period of (6) months on Retco brand trailers; except as herein limited herein, from date of original retail purchase. This warranty shall extend to the original owner (purchaser) and is non-transferable. The obligation of this Warranty shall be limited to repairing or replacing any part or parts which, in the opinion of the Warrantor, shall be proven defective in materials or workmanship under normal use and service during the appropriate Warranty period.

Items excluded from this (6) month warranty: electric wiring, tail lights, marker lights, wiring connectors, wood decking, paint (powder coating), and wheels; warranted for a **forty-five (45)** day period from the date of purchase by the original purchaser. Paint will NOT be warranted if trailer is exposed to roads with frequent salt conditions.

***Items excluded from warranty*** to which the warranty assumes absolutely no responsibility for claims related to or implied to the following:

- 1) Defacing (scratches, dents, chips, tears, and defacing on any surface not caused by warrantor.
- 2) Damages resulting from original purchaser's lack or negligence to perform routine maintenance.
- 3) Damages resulting from unauthorized repairs, abuse, misuse, or neglect of any sort.
- 4) Damage resulting from improper hitch ball and/or tow vehicle hook up.
- 5) Damage caused to contents within or out of trailer.
- 6) Component parts which are covered by separate Supplier Warranty such as warranties given by the manufacturer of tires, axles, jacks, couplers and any service warranty the manufacturer may imply. Rettig Enterprises reserves the right for final determination whether or not the product has been abused or misused by the purchaser.
- 7) Any parts or components supplied by the purchaser to be attached or connected in any way to the product, and any damages that are a result of those parts and components supplied by the purchaser.
- 8) Trailer which has been modified, repaired, or altered in any way without the express written consent of Warrantor. Modified includes, but is not limited to, any special modifications such paint or exterior modifications (such as buildings) not manufactured or supplied by Retco trailer Mfg.

**Warrantors Obligation-How To Get Warranty Service**

All defective products shall be delivered to Warrantor's address listed herein. Unless prior written approval is obtained, Warrantor will not be obligated in any way to pay for any repairs made without authorized approval. It is the sole responsibility of the Purchaser to transport the equipment to Warrantor's manufacturing facility or to an authorized repair facility as determined by Warrantor. Retco Trailer Mfg. shall remedy defects within a reasonable period of time, not to exceed thirty (45) days after delivery by Purchaser.

**Purchasers Obligation**

Purchaser must notify the Warrantor, at the address contained herein, of any defect within ten (10) days after it is, or should have been discovered. Purchaser must pay all service, towing and transportation charges incurred to obtain warranty service.

### **Disclaimer Of Consequential And Incidental Damages**

The original purchaser of warrantor's product and any person to whom the product it transferred, and to any person who is an intended user and/or beneficiary of the product shall not be entitled to recover from warrantor any consequential or incidental damages resulting from any defect in the product. Damages including:

- \* Loss of use of trailer
- \* Loss of revenues or any other commercial losses
- \* Subsequent use of rental equipment
- \* Loss of time and inconvenience

### **Limitations And Disclaimer Of Implied Warranties**

Warrantor expressly limits the duration of all implied warranties merchantability, all implied warranties of fitness for a particular purpose and other implied warranties to the warranty period of six (6) months. The warrantor expressly disclaims all implied warranties of merchantability and all implied warranties of fitness for a particular purpose after expiration of the warranty period.

There is no warranty made by warrantor beyond that contained in this warranty.

### **Design Changes**

Warrantor reserves the right to change the design of its product from time to time without notice and with no obligation to make corresponding changes in its products previously manufactured.
